Subject : Provisions for Registration for Class IX/Enrollment for Class X in respect of displaced students

No. Ex/85/94-Vol-I(Pt-I)Relief2023 In continuation of this office Notification No. AC/75/92(Pt-III)NIC/20 dated 22-03-2024 and in consonance with the provisions of exemption of fees in respect of displaced students mentioned in this office Notification of even No. dated 30-08-2023, it is hereby notified for information of all concerned displaced students/candidates, their parents and the Heads of Institutions that fees for Registration for Class IX and Enrollment for Class X shall be exempted only for the students/persons displaced by the prevailing situation on production of either:

- a) Authorized letter issued by Zonal Educational Officer/Nodal Officer of Relief Camp/Convener of Relief Committee; or
- b) Authorized letter issued by Relief Committee/Co-Ordinating Committee of Relief Camp.
- 2. Further, Registration for Class IX / Enrolment for Class X in respect of the displaced students/candidates shall be done in ONLY OFFLINE MODE by the Heads of Institutions for the software developed for online registration/enrolment does not have features for exemptions of fees.
- 3. All Heads of Institution whose displaced students/candidates are required to be registered for Class –IX and enrolled for Class X should fill up the Annexure –I and Annexure –II as enclosed (in lieu of the online submission) and submit the same along with copies of necessary documents to the Controller of Examinations, BSEM within the stipulated last date i.e. on or before 30-06-2024 without fail.
- 4. Heads of Institutions concerned shall be held responsible for failure to register students for Class IX/Enrollment of students for Class X within the time frame for all students in his/her school.
